- 1) When the pup is received, the owner has 3 business days to take the pup to the veterinarian of their choice. If the pup is found to be in sound physical condition by the veterinarian, the buyer will retain the pup and the seller will be held harmless and free from any liability pertaining to the pup's health. If the pup is found to be in poor physical condition by the veterinarian, the buyer shall provide the seller with a copy of the veterinarian's report and return the pup at the buyer's expense within 2 days of the exam. The seller, while desiring to work with the buyer to the buyer's satisfaction, retains the final say as to whether the purchase price of the pup will be refunded, or a replacement pup will be given.
- 2) Brown's Labradoodles pups have a 2-year warranty against defects and genetic illness that the parent breed has been tested for. If a problem should occur the seller, while desiring to work with the buyer to the buyer's satisfaction, retains the final say as to whether the purchase price of the pup will be refunded, or a replacement pup will be given. Replacement pups will be of a like kind. F1 for a F1, F1B for a F1B, Australian for Australian, multigen Australian for multigen Australian. Claims will be honored with a certified report from a licensed veterinarian. Seller reserves the right to a second opinion at the seller's expense. If a pup is found to be overweight or in a poor state of health or nutrition, the genetic guarantee will be void. No responsibility for health-related issues or death are assumed by the seller for reactions caused by vaccinations, medications, topical or orally given flea and tick treatments.

- 3) Pups will be scheduled for a vet check at 6-7 weeks of age. Minor under bites will not be discussed / disclosed as they do not pose a problem with the Labradoodle as it does with some other breeds. If under bites are major and prevalent it will be disclosed when the puppy picking takes place so it can be observed by all. If any congenital issues should arise during the puppy check it would be disclosed to the person who has chosen the puppy. No breeding rights are given for a pup that has been purchased as a companion pup.
- 4) Pups purchased as "companion pups" are to be spayed / neutered no later than 8 months of age. Reminders will be sent and registration certificates will be withheld until evidence of the spay / neuter has taken place.
- * spay / neuter is critical to Brown's Labradoodles LLC in keeping contract terms for breeding dogs that Brown's Labradoodles LLC has purchased from other breeders. This evidence of record must be sent by Brown's labradoodles LLC to various breeders that Brown's Labradoodles LLC has purchased pups from for breeding purposes.
- 5) The buyer agrees to provide his / her pup with a clean, comfortable environment, prompt medical attention when needed, proper grooming and maintenance, and a loving lifetime commitment. This includes, but is not limited to, keeping the pup parasite free, up to date on vaccinations, proper nutrition and having fresh water available at all times.
- 6) If at any time the pup / adult dog should be in need of a home in his / her lifetime, the buyer must notify the seller who is given the first option in resuming full ownership. No refunds will be given for this cause. Should any circumstances arise that affect the quality of life of the pup / dog, the seller is to be informed so that they may participate in determining the future of the pup / dog. Under no circumstances will this pup / dog be traded, sold, leased or given away to any pet shop, research laboratory, animal shelter or similar facility.
